ROLL CALL AND PLEDGE OF ALLEGIANCE

APPROVAL OF MINUTES

Motion by Alder Wood, seconded by Alder Radermacher, to approve the Minutes of the March 20 and April 3, 2023 City Council meetings. Motion carried.

G.1.a Consideration of Resolution 23-4-2620 Award of Design and Bidding Services for the 2023-2024 Street and Utility Improvements Project.

Alder Wood explained that there are two agenda items for the four summer concerts. The state law limits the number of Temporary "Class B" Wine licenses that groups are allowed to get per 12-month period to two. Wine is classified as liquor so it is more restricted than beer. This would allow for both beer and

wine at two events. Past events were exempt from the fencing requirement due to the Parks Department selling the beer.

G.2.e Consideration of Resolution 23-4-2622 Authorizing a Representative of the City of Monona to Submit the Grant Application and Sign Necessary Documents to be Eligible for the Runoff Management Grants Offered by the Wisconsin Department of Natural Resources.

Manager Bruun explained the grants will help fund the City's Storm Water Quality Improvement Plan in 2024. The City will be seeking a grant amount of \$55,100 with a 50/50 cost share.

REPORTS

1. Updates/Discussion on Diversity, Equity, and Inclusion (DEI) Efforts

Alder Radermacher reported the Wisconsin Academy of Sciences is hosting a virtual meeting on April 18 with Sara Smith. She will be talking about resilience and how climate change has affected those people of the first nations.

Interim Administrator/Finance Director Houtakker reported that City staff met with Nehemiah to continue working through goals.

2. Update/Discussion on Sustainability Efforts.

Alder Radermacher reported that it is international dark sky week. While light pollution seems harmless, it is actually far reaching. The Dane County Regional Housing Strategy is hosting a webinar regarding the need for housing developments to be sustainable.

Manager Bruun reported the City applied for an \$80,000 grant to retrofit residential streetlights to LED. There are two more projects for conversions and the City will apply for the grant for each project. LED

lighting is more efficient and can be directed better than ornamental lighting, which the City currently has a lot of.

3. Committee Reports.

Alder Radermacher reported the electronics recycling event that occurred on April 15 had a steady stream of traffic. Sustainability Committee will be focusing on No Mow May. No Mow May helps the early season pollinators, if you have little flowers do not mow them. Landmarks visited and discussed the pagoda. The Monona Go app is now available on your phone.

Alder Wood reported the second public information meeting is April 19 at the High School. The MPO discussed the Carbon Reduction Program (CRP). The Joint Finance decided that MPO's could only finance certain categories; concerns have been raised about the legal ramifications of limiting what the federal program allows.

Alder DePula reported that Mass Transit Commission met and discussed the results of the survey, which were split almost equally between in favor of and opposed to Madison Metro. Shout out to Addy for all time she has spent crafting the survey and going through all the data after the survey closed.

Clerk Houser reported the April election had a 72.19% voter turnout in Monona.

Mayor O'Connor reported that staff is still working on the details of complying with the Short Term Rental (STR) ordinance. Director Houtakker explained that staff is still working to get a meeting with the software company to assist with STR compliance. The San Damiano public input meeting is April 19 and MSA will be showing three concepts. After the meeting, a survey will be released. A recorded presentation will be available on the City's website for anyone unable to attend in person. Condolences to the family of Charlotte Smith, a long time Library employee who passed away. Her family will be having a memorial service on May 20. The Reorganizational meeting will be April 18 at 5:30 pm at City Hall.
